- 1. Sealed tenders are invited from vendors, for Annual Maintenance Contract (AMC) of Photostat Machines (7 Sharp, 1 Ricoh & 2 Sindoh) total 10 machines in the office of Board of Revenue for Rajasthan, Ajmer and 1 Sharp Photostat Machine in the office of Revenue Department, Jaipur which shall be valid till 31.03.2025 from the date of awarding of contract which may be extended for further period of three months on satisfactory performance and mutual consent. The bid document can be downloaded from Revenue Board website www.landrevenue.rajasthan.gov.in/bor and www.sppp.in.
- 2. Sealed tender should be submitted to the undersigned latest by 10:00 AM on 29.09. 2023 at the address "REGISTRAR, BOARD OF REVENUE FOR RAJASTHAN, AJMER" in Two Envelopes. The words "First Envelope TECHNICAL BID FOR AMC of the PHOTOSTAT MACHINE" and "Second Envelope FINANCIAL BID for AMC of the PHOTOSTAT MACHINE (NOTE: This envelope must include separate Financial Bids of the different OEMs in each separate sealed envelope)" must be super scribed on the envelope. The Technical tender / quotation will be opened @ 11:00 AM on the same day and the representative of the firm may remain present, if they so desire, and technically qualified bidders will be informed accordingly for Financial bid opening date & time.
- 3. The terms and conditions of the contract for the **PHOTOSTAT MACHINE** are as under:
- (i) The firm should have experience of at least One (01) year of doing aforementioned maintenance job in the Government Department. The bidder will have to submit declaration regarding this mentioning the name of the department in which bidder has done AMC. Provided in the tender document itself in the form of Annexure-G.
- (ii) The firm should also have a GST Registration (In case of non availability Self Declaration must be submitted with respect to the Registration) and PAN No., etc..
- (iii) The firm will also have to submit service report whenever called for servicing the machine to this office.
- (iv) The repair work of the machine are to be carried out in the premises of the said department and no relaxation would be given to take out any part / machine outside the premises for repairing etc (In case required then prior approval must be taken). The parts replaced

should be original in make with a proper company mark for smooth & effective functioning.

- (v) The complaint should be attended promptly on receipt of telephone call including on holidays.
- (vi) The bidder can get clarifications regarding tender in writing max. upto 2 days before the opening of technical bid.
- (vii) The contract can be terminated by the department without assigning any reason. If the work of the contractor is found to be unsatisfactory, it would be entrusted to any other party at the risk and cost of the defaulting contractor. In this connection, decision of the department shall be final and binding upon the contractor and the rules of GF & AR will prevail.
- (viii) The successful bidder will have to furnish a Performance Security of 5% of the amount of supply order within specific period from the date of giving intimation to him of acceptance of his tender / quotation. The security deposit shall be in the form of DD/Cash/Banker's Cheque in favour of "REGISTRAR, BOARD OF REVENUE FOR RAJASTHAN, AJMER." The security deposit will be refundable after the expiry of the contract period successfully and to the satisfaction of the competent authority. The Government has right to forfeit the security money, in case of non-cooperation, disobeyance of the instructions, non-attending of the complaint within time or due to any damage of equipment on the part of the bidder / employee of the bidder etc..
- (ix) No advance shall be made to the agency, however monthly payment shall be made subject to satisfactory report received from the users. The rate contract shall be valid for a minimum period of one year from the date of notification of the rate contract. However, the contract period may be extended further, subject to satisfactory services.
- (x) The firm blacklisted / debarred at any point of time by any Government Department need not apply. In case, the fact is concealed and it comes to the notice of this office during the period of the contract, the contract will be terminated straightaway and the security deposit will be forfeited. If the fact comes to notice before award of contract the bid will be rejected outrightly. The bidder will have to submit declaration regarding this in the form of Annexure-F.
- (xi) If any complaint is not attended / replacement of parts / consumable under AMC a penalty of Rs. 1000 (Rs. One Thousand Only) per day will be charged for delay beyond / after the one day or upto 10 days, then termination of the contract will be done.
- (xii) Before submitting the tender / quotation the bidder must put his signature along with seal & stamp of his firm on every page of Bid Document as a token of acceptance of the terms & conditions mentioned in the Bid Document.
- (xiii) This office is not bound to accept the rates of the lowest tenderer. The decision of the committee regarding finalization of the rate will not be challengeable. No representation regarding this will be entertained.
- (xiv) The rates quoted shall be mentioned by the tenderer both in words and figures (quoted with ball point pen in the relevant column). The rates quoted in words shall be treated as final Additional information, if any, having relevance on the subject may also be furnished in the quotation.
- (xv) The bidders can visit the office on or before 29.09.2023 to check / see the condition of the machine,.

- (xvi) The provision of Risk and Cost will be applicable as per rules.
- (xvii)Participation of bidders: The bidders belonging to or with beneficial ownership from countries sharing land border with India, for participation in any public procurement in the State, shall only be allowed after prior registration with the Industries Department of the Government of Rajasthan. For the purpose of this rule "Bidder from a country which shares a land border with India" means,-
 - A. An entity incorporated, established or registered in such a country;
 - B. A subsidiary of an entity incorporated, established or registered in such a country;
 - C. An entity substantially controlled through entities incorporated, established or registered in such a country;
 - D. An entity whose beneficial owner's situated in such a country;
 - E. An Indian (or other) agent of such an entity;
 - F. A natural person who is a citizen of such a country;
 - G. A consortium or joint venture where any member of the consortium or joint venture falls under any of the above."
- (xviii) Year of Purchase of the different machines has been mentioned in the Price schedule.
- (xix) The Annual Maintainence Contract shall include service, replacement of wiring and spare parts.
- (xx) In case of Small Scale Industries of Rajathan the Bid Security shall be Rs 1500/- and Performance Security shall be 1% of the amount of quantity ordered for supply of service.
- (xxi) If by any means the rate of taxes are amended by the Government in the said period and the bidder quute the same percentage, then the payment shall be made accordingly.
- (xxii)To reduce transaction cost of doing business for mirco, small and medium enterprises of the state, having acknowledgement of Entreprenerus Memorandum-II/Udyog Aadhar Memorandum as mentioned in Mirco, Small and Medium Enterprises Development Act, 2006, issued by the competent authority shall be faciliated, on furnishing of a self attested copy of acknowledgement of Entrepreneurs Memorandu-II/Udyog Aadhar Memorandum, as follows or as amended in the Rajasthan Transparency in Public Procurement Rules, 2013:
 - a) Bidding Document shall be of Rs 1000/-
 - b) Bid Secutiy shall be Rs 4000/-
 - c) Performance Security shall be 1% of the amount of quantity ordered for supply of service

(xxiii) Mode of Payment of following fees:-

- a) Bid Document Fee: May be given in the form of cash, a banker's cheque or demand draft or bank guarantee, in specified format, of a scheduled bank or deposit through eGRAS (Budget Head-0075-00-800-52-01)
- b) Bid Security: May be given in the form of cash, a banker's cheque or demand draft or bank guarantee, in specified format, of a scheduled bank or deposit through eGRAS (Budget Head-8443-00-103)
- c) Performance security shall be furnished in any one of the following forms-
 - (a) deposit though eGRAS;

- (b) Bank Draft or Banker's Cheque of a scheduled bank;
- (c) National Savings Certificates and any other script/instrument under National Savings Schemes for promotion of small savings issued by a Post Office in Rajasthan, if the same can be pledged under the relevant rules. They shall be accepted at their surrender value at the time of bid and formally transferred in the name of procuring entity with the approval of Head Post Master;
- (d) Bank guarantee or electronic bank guarantee (e-BG) of a scheduled bank
- (e) Fixed Deposit Receipt (FDR) of a scheduled bank. It shall be in the name of procuring entity on account of bidder and discharged by the bidder in advance. The procuring entity shall ensure before accepting the Fixed Deposit Receipt that the bidder furnishes an undertaking from the bank to make payment/premature payment of the Fixed Deposit Receipt on demand to the procuring entity without requirement of consent of the bidder concerned. In the event of forfeiture of the performance security, the Fixed Deposit shall be forfeited along with interest earned on such Fixed Deposit.
- (xxiv) The Bidder have to submitt the sealed envelope before the date prescribed. The envelope must contain Technical Bid sealed envelope and Financial Bid sealed envelope. The Financial Bid envelope must contain the other 3 sealed envelope i.e. Financial Bid1-Sharp, Financial Bid 2- Ricoh & Financial Bid 3- Sindoh.
- (xxv) The bidder is free to participate in only one or two or in all categories of the Annual Maintainence Contract of Photostat Machine having 3 different OEMs i.e. Sharp, Ricoh and Sindoh.
- (xxvi)One of the Photostat Machine **SHARP** MX -M754N is established at Revenue Department, Jaipur whereas other Machine are commissioned in Board premises itself.
- (xxvii)If mistakenly the bidder put all the Price Schedule i.e. Page No. 7,8,9,10 in single envelope then the Procurring Entity shall not open the envelope even if the bidder is technically qualified. The Procurring Entity can also return the same envelope and ask the bidder in writing to make separate Financial Bid, if it deems fit.
- (xxviii) The Tendered value of the Bid i.e. Rs 800000/- is tentative, If the Procurring Entity does not procure any subject matter of procurement or procures less than the total tender amount specified in the Bidding Document due to change in circumstances, the Bidder shall not be entitled for any clain or compensation and in case the Procurring Entity placed repeat order for extra items or additional quantity then the limit of such procurement shall be 50% of the tendered value i.e. Rs 400000/-.
- (xxix) In case Procurring Entity extend the valid of the contract, then the bidder must submit a fresh agreement and Security as per rules.

A Conflict of Interest is considered to be a siltation in which a party has interests that could improperly influence that party's performance of official duties or responsibilities, contractual obligation, or compliance with applicable laws and regulation.

A Bidder may be considered to be Conflict of Interest With one or more parties in a bidding process if, including but not limited to;

- A. Have controlling partners/shareholders in common; or
- **B.** Receive or have received any direct or indirect subsidy from any of them; or
- C. Have the same legal representative for purposes of the bid; or
- **D.** Have a relationship with each other, directly or through common third parties. That puts them in a position to have access to information about or influence on the bid of another bidder or influence the decision of the procuring entity regarding the bidding process's
- **E.** The bidder participates in more than one bid in a bidding process. Participation by a bidder in more then one bid will result in the disqualification of all bids in which the bidder is involved, however, this does not limit the inclusion of the same sub contraction, not otherwise participating as a bidder, in more than one bid; or
- **F.** The bidder or any of its affiliates participated as consultant in preparation of the design or technical specifications of the good, works or services that are the subject of the bid; or

1) Filing an appeal

If any Bidder or prospective bidder is aggrieved that any decision, action or omission of the Procuring Entity is in Contravention to the provision of the Act or the Rules or the Guidelines issued there under, he may file an appeal to First Appellate Authority, as specified in the Bidding Document with in a period of ten days from the date of such decision or action, omission, as the case may be, clearly giving the specific ground or grounds on which he feel aggrieved:

Provided that after the declaration of a Bidder as successful the appeal may be filed only by Bidder who has participated in procurement proceedings:

Provided further that in case a procuring Entry evaluates the Technical Bids before the opening of the Financial Bids, an appeal related to the matter or financial Bids be filed only by a Bidder whose Technical Bid is found to be acceptable.

- 2) The officer to whom an appeal is filed under Para (1) shall deal with the appeal as expeditiously as possible and shall endeavour to dispose it of within thirty days from the date of the appeal.
- 3) If the officer designated under Para(1) fails to dispose of the appeal filed within the period specified in Para(2), or if the Bidder or prospective bidder or the procuring Entity is aggrieved by the order passed by the First Appellate Authority, the Bidder or prospective bidder or prospective bidder or the procuring Entity, as the case may be, may file a second appeal to second Appellate Authority specified in the Bidding Document in this behalf with in fifteen days from the expiry of the period specified in Para(2) or of the date of receipt of the order passed by the First Appellate, as the case may be.

4) Appeal not to lie in certain case

No appeal shall lie against any decision of the procuring Entity to the following matters, namely:-

- a) Determination of need of procurement;
- **b)** Provision limiting participation of Bidder in the Bid process;
- c) The decision of whether or not to enter into negotiations;
- **d**) Cancellation of a procurement process;
- e) Applicability of the provisions of confidentiality;

5) Form of Appeal

- **a)** An appeal under Para (1) or (3) above shall be in the annexed from along with as many copies as there are respondents in the appeal.
- **b**) Every appeal shall be accompanied by an order appealed against, if any, affidavit verifying the facts stated in the appeal and proof of payment of fee.
- c) Every appeal may be presented to first appellate authority second appellate, as the case may be, in person or through registered post or authorized representative.

6) Fee for filing appeal

- a) Fee for first appeal shall be rupees two thousand five hundred and for second appeal shall be rupees ten thousand, which shall be non-refundable.
- **b**) The fee shall be paid in the from bank demand draft banker's cheque of a Scheduled Bank in India payable in the name of Appellate Authority concerned.

7) Procedure for disposal of appeal

- a) The first Appellate Authority or Second Appellate Authority, as the case may be, upon filing of appeal, shall issue notice accompanied by copy of appeal, affidavit and documents, if any, to the respondents and fix date of hearing.
- **b**) On the date fixed or hearing, the first appellate authority or second appellate authority, as the case may be, shall-

- i. Hear all the parties to appeal present before him; and
- **ii.** Peruse or inspect documents, relevant records or copies there of relating to the matter.
- c) After hearing the parties, perusal or inspection of documents and relevant records or copies there of relating to the matter, the appellate authority concerned shall pass an order in writing and provide the copy of order to the parties to appeal free of cost.
- **d**) The order passed under sub-clause(c) above shall also be placed on the State public procurement portal.

Annexure D: Additional Conditions of Contract

1. Correction of arithmetical errors

Provided that a Financial Bid is substantially responsive, the Procuring Entity will correct arithmetical errors during evaluation of Financial Bids on the following basis:

- i. if there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected, unless in the opinion of the Procuring Entity there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price shall be corrected;
- ii. if there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected; and
- iii. if there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject to (i) and (ii) above.

If the Bidder that submitted the lowest evaluated Bid does not accept the correction of error, its Bid shall be disqualified and its Bid Security shall be forfeited or its Bid Securing Declaration shall be executed.

2. Procuring Entity's Right to vary Quantities

- i. If the Procuring Entity does not procure any subject matter of procurement or procures less than the quantity specified in the Bidding Document due to change in circumstances, the Bidder shall not be entitled for any claim or compensation except otherwise provided in the Conditions of Contract.
- ii. Repeat orders for extra items or additional quantities may be placed, if it is provided in the bidding documents, on the rates and conditions given in the contract if the original order was given after inviting open competitive bids. Delivery or completion period may also be proportionately increased. The limits of repeat order shall be as under
 - a) 50% of the quantity of the individual items and 50% of the value of original contract in case of works; and
 - **b)** 50% of the value of goods or services of the original contract.]

3. Dividing quantities among more than one Bidder at the time of award (In case of procurement of Goods)

As a general rule all the quantities of the subject matter of procurement shall be procured from the bidder, whose Bid is accepted. However, when it is considered that the quantity of the subject matter of procurement to be procured is very large and it may not be in the capacity of the Bidder, whose Bid is accepted, to deliver the entire quantity or when it is considered that the subject matter of procurement is of critical and vital nature, in such cases, the quantity may be divided between the bidder, whose Bid is accepted and the second lowest Bidder or even more Bidders in the order, in a fair, transparent and equitable manner at the rates of the Bidder, whose Bid is accepted.
