NUTTFICATION

In exercise of the powers conferred by clause (xviii) of sub-section (2) of section 261 read with section 101 of the Rajasthan Land Revenue Act, 1956 (Rajasthan Act 15 of 1956), the State-Government hereby makes the following rules further amend the Rajasthan Land Revenue (Allotment of Land for crace and Purposes) Rules, 1970, namely:-

- 1. 12 These rules may be called the Rajasthan Land Revenue (rule) at of land for Agricultural Purposes) (Second Amendment) Rules, 1999.
 - (2) They shall come into force at once.
- 2. In sub-rule (1) of rule. 11 of the Rajasthan Land Revenue (Allotment of land for Agricultural Purposes) Rules, 1970, hereinafter refrended to as the said Rules, the following proviso shall as added, namely:-

removided that where an allottee after conferment of knatedari right under these rules transfer as such land, he shall not be treated as landless agriculturist for the purpose of allotment.

- C. In rule 14 of the said ules.~
 - (a) in sub-rule (1), for the expression "10 years", wherever occurring the expression "3 years" shall be substituted.
 - (b) sub-rule (1) shall be subscituted by the following.~
 - (3) The allottee shall have to bring the land under cultivation and shall tilise it properly.
- 4. In sub rule (1) of rule 18 of the said rules, for the expression "three years" shall be substituted.

- 5. In clause 7 of Form V appended to the said Rules:-
- (a) in sub-clause (1), for the expression "10 years" the expression "three years" shall be substituted.
 - (b) Sub-clause (3) shall be substituted as follows. The allottee shall have to bring the land under
 - cultivation and shall utilise it properly.
- 6. In Form V-B appended to the said rules, in sub-clause
 (1) of Clause 4, for the expression "10 years" the expression "three years" shall be substituted.
