NOTIFICATION

In exercise of the powers conferred by clause (xviii) of sub-section (2) of section 261 of the Rajasthan Land Revenue Act, 1956 (Rajasthan Act 15 of 1956), read with section 101 of the said Act, the State Government hereby makes the following rules further to amend the Rajasthan Land Revenue (Allotment of Land for Agricultural Purposes) Rules, 1970, namely :-

1. (1) These rules may be called the Rajasthan Land Revenue (Allotment of Land for Agricultural Purposes) (Amendment) Rules, 2000.
(2) They shall come into force w.e.f. 15th August, 2000.

2. Amendment of Rule 2. In rule 2 of the Rajasthan Land Revenue (Allotment of Land for Agricultural purposes) Rules, 1970, hereinafter referred to as the said Rules, in proviso to clause (iii-B), after category (b), the following new category (c) shall be added, namely :-

"(c) a married person whose wife or husband, as the case may be, holds land, including any land which has been previously allotted to him or her, jointly or severally, is more than the area prescribed in rule 12".

3. Amendment of Rule 8. In rule 8 of the said rules, after sub-rule (1) and before sub-rule (2), the following new sub-rule shall be inserted, namely :-

"(1-a) Where an applicant is a married agriculturist, the application for allotment shall be submitted in the name of both husband and wife."

4. Amendment of Rule 14. After sub rule (1) of rule 14 of the said rules, the following new sub-rule (1-a) shall be inserted, namely:-

"(1-a) - In case where allotment of land is made to a married agriculturist, the allotment shall be made in the joint name of husband and wife and the allottees, in such case, shall be deemed to be joint allottees".

5. Amendment of FORM III. In Form III appended to the said rules,

(1) for the existing word "I", "me", "my" or "applicant" wherever occurring, the expression "I/We", "me/us", "my/our" or "Applicant/Applicants" respectively, shall be substituted.

(2) after the expression "occupation" and before the words "state as under", the following shall be inserted :-

" or

(In case of married applicant)

We, ShriS/O Age..... Occupation....(husband)
and Smt.W/O.....Age.....Occupation(wife)
R/O..... Tehsil..... District

6. Amendment of Form V, V-A and V-B - In Form V, V-A and V-B appended to the said rules, after serial No. 1 and before serial No. 2, the following shall be inserted, namely :-

"Name of the Joint allottees:

Shri----- S/O----- Age----- (husband)
and Smt.----- W/O----- Age----- (wife)
R/O----- Tehsil----- District-----".

7. Amendment of Form VI - In Form VI appended to the said rules, after the existing expression "Resident of....." and before the words "under the Rajasthan" the expression

"in case of married allottee, to Shri----- S/O----- Age-----
and Smt.----- W/O----- Age----- R/O-----." and
for the existing expression " Shri----- in accordance" the expression
~~Shri----- Smt.-----~~ in accordance " shall be inserted.
