NOTIFICATION

In exercise of the powers conferred by Section 102 of the Rajasthan Land Revenue Act, 1956 (Rajasthan Act 15 of 1996) the State Government hereby makes the following amendment in this Department notification No.- F-6 (12)Rev/Gp-6/99/30 dated 18.9.1999 namely.-


1. In para (a) the words "The Rajasthan State Electricity Board" shall be substituted by the "Rajasthan Rajya Vidhyut Utpadan Nigam Limited; Rajasthan Rajya Vidhyut. Parasaran Nigam Limited; Jaipur Vidhyut. Vitæaran Nigam Limited, Jaipur; Ajmer Vidhyut Vitaran Nigam Limited, Ajmer and Jodhpur Vidhyut Vitaran Nigam Limited, Jodhpur".

2. Under the heading terms and conditions (a) The condition No 1 shall be substituted by the following.-

"1. The allotment to Rajasthan Rajya Vidhyut Utpadan Nigam Limited; Rajasthan Rajya Vidhyut Prasaran Nigam Limited; Jaipur Vidhyut Vitran Nigam Limited, Jaipur; Ajmer Vidhyut Vitaran Nigam Limited, Ajmer and Jodhpur Vidhyut Vitaran Nigam Limited, Jodhpur shall be made as per condition No 3 but all amount so payable shall be adjusted by the State Government as subvention to them. All allotments to Rajasthan State Electricity Board or corporations Limited, as the case may be, made prior to the date of this Notification shall also be made as per condition No 3/^{at price}prevalling at the time of allotment and all such arrears shall also be adjusted against the subvention."

(b) In condition No 3 the words "except Rajasthan State Electricity Board" shall be deleted.
