NOTIFICATION

In exercise of the powers conferred by sub-section (4) of section 4, read with clause (i) of sub-section (2) of section 261 of the Rajasthan Land Revenue Act, 1956 (Rajasthan Act No. 16 of 1956) the State Government hereby makes the following rules further to amend the Rajasthan Land Revenue (Qualifications and Conditions of Service of Chairman and Members of the Board) Rules, 1971; namely:-

1. (1) These rules may be called the Rajasthan Land Revenue (Qualifications and Conditions of Service of Chairman and Members of the Board) (Amendment) Rules, 2001.  
(2) They shall come into force from the date of their publication in the official Gazette.
2. Amendment of Rule 4.- In rule 4 of the Rajasthan Land Revenue (Qualifications and Conditions of Service of Chairman and Member of the Board) Rules, 1971, hereinafter referred to as the 'said rules';
  - (i) The existing clause (c) shall be substituted by the following:-  
"(c) an advocate qualified for appointment as a Judge of the High Court and have completed 50 years of age on 1st January of the year in which appointment is made."
  - (ii) after the existing clause (c) following new clause (d) shall be inserted:-  
"(d) a member from super senior scale of the Rajasthan Administrative Service and have completed 54 years of age and 20 years of service in Rajasthan Administrative Service".
3. Amendment of Rule 5-A.- In rule 5-A of the said rules the existing expression "four members" shall be substituted by the expression "two members".



4. Insertion of new rule 5-B.- After the existing rule 5-A, a new rule 5-B shall be inserted as follows:-

"5-B- Appointment of Members from super seniority scale of Rajasthan Administrative Service I- The Board shall have two members fulfilling the qualifications prescribed in clause (d) of rule 4 who shall be appointed by the Government on the recommendations of a committee consisting of the following :-

5. Insertion of new Rule 7-A.- After rule 7 of the said rules, a new rule 7-A shall be inserted as follows:-

"(7-A), Except as hereinafter provided in these rules, the terms and conditions of the members appointed from the Rajasthan Administrative Services shall be regulated by the rules applicable to the members of that service."


6. In CHAPTER II, the existing heading "conditions of service of members appointed from the Rajasthan Higher Judicial Service and Advocates" shall be substituted by the following :-

"conditions of service of members appointed from the Rajasthan Higher Judicial Service, Rajasthan Administrative Service and Advocates."

7. Amendment of Rule 12.- In rule 12 of the said rules, after the existing expression "the Rajasthan Higher Judicial Service" and before the existing expression "who has already taken", the expression "or the Rajasthan Administrative Service" shall be inserted.

8. Amendment of Rule 13.- In rule 13 of the said rules;

- (1) the existing expression "rule 6" shall be substituted by the expression "rule 5-B and rule 6".




- (ii) the existing sub-rule (2) shall be substituted by the following:-
- "(2) the dearness allowance admissible to a member appointed from the Rajasthan Higher Judicial Service, Rajasthan Administrative Service and from advocates shall be the same as is admissible to a member appointed from the Indian Administrative Service."
9. Amendment of Rule 14,- In rule 14 of the said rules;
- (i) the existing clause (a) of sub-rule (1) shall be substituted by the following:-
  - (a) The term of office of member of the Board appointed under rule 6 from the advocates shall be for four years or 60 years of age whichever is earlier. Provided that on satisfactory service this term of office may be extended for another two years or 60 years of age whichever is earlier, by the committee constituted under rule 6 (2) on the recommendation of the Chairman, Board of Revenue.
  - (ii) after clause (b) of sub-rule (1), a new clause (c) shall be inserted as follows:-
  - (c) A member of the Board appointed under rule 5-B from the Rajasthan Administrative Service shall hold office till he continues to be a member of that service, subject to further extension for two years by the Government on the recommendation of the committee constituted under rule 5-B.
  - (iii) in sub-rule (3), after the existing expression "the Rajasthan Higher Judicial Service" and before the existing expression "after he has attained", the expression "or a member appointed from Rajasthan Administrative Service" shall be inserted.


