NOTIFICATION

In exercise of the powers conferred by sub-section (2) of section 261 of the Rajasthan Land Revenue Act, 1956 (Rajasthan Act No. 15 of 1956), the State Government hereby makes the following rules further to amend the Rajasthan Land Revenue (Allotment of Tank-Bed Lands for Cultivation) Rules, 1961, namely.--

1. Short title and commencement .- (1) These rules may be called the Rajasthan Land Revenue (Allotment of Tank-Bed Lands for Cultivation) (Amendment) Rules, 2001.

(2) They shall come into force at once.

2. Insertion of new rule 6 B.- After rule 6-A and before rule 7 of the Rajasthan Land Revenue (Allotment of Tank-Bed Lands for Cultivation) Rules, 1961, the following new rule 6-B shall be inserted, namely.--

"6-B Conferment of Gair Khatadari rights in certain cases in Ajmer District.- Notwithstanding any thing contained in these rules, Tank-Bed Land in Ajmer district on which Khatadari Rights were given to the cultivators during the process of "Bhoo Abhilekh Sansodhan" in the period of 1970 to 1972 and later on such land was entered as "Saival Chak" in record of rights such cultivators may be conferred Gair Khatadari rights by Sub-divisional Officer, subject to the following conditions.--

(1) Such cultivators are in continuous possession of land from 1972.

(2) Gair Khatadari Rights are to be conferred without any limit of period and they shall continue to remain Gair Khatadar and no Khatadari rights shall accrue to such cultivators.


(3) The Land held by such cultivator and Land on which Gair Khatadari Rights are to be conferred under this rule shall not exceed the Ceiling area applicable to him under the Rajasthan Imposition of Ceiling on Agricultural Holding Act, 1973.

(4) During the period the Land remain sub-merged in water, cultivators shall have no right to cultivate such land and for that period only twenty five percent rent shall be payable.

(5) Such Gair Khatadari Rights are heritable but not transferable to others.


(6) Such cultivators shall cultivate Land personally.
