NOTIFICATION

In exercise of the powers conferred by clause (xviii) of sub-section (2) of section 261 read with section 101 of the Rajasthan Land Revenue Act, 1956 (Rajasthan Act 15 of 1956, the State Government hereby makes the following rules further to amend the Rajasthan Land Revenue (Allotment of Land for Agricultural Purposes) Rules, 1970, namely:-


1. Short title and commencement.- (1) These rules may be called the Rajasthan Land Revenue (Allotment of Land for Agricultural Purposes) (Amendment) Rules, 2001.

(2) They shall come into force at once.

2. Amendment of rule 20.- After sub-rule (1) and before sub-rule (2) of rule 20 of the Rajasthan Land Revenue (Allotment of Land for Agricultural Purposes) Rules, 1970, the following new sub-rule (1-A) shall be inserted, namely:-


"(i-A) Notwithstanding any thing contained in these rules, the cultivators who were conferred Khatodari Rights during the process of "Bhoo Abhilekh Sansodhan" in Ajmer District in the period of 1970 to 1972 and subsequently whose Khatodari were cancelled and land was recorded as Sival Chok in revenue record, the sub-divisional officer on the advice of the advisory committee may regularise such land in favour of such cultivators upto 15 bighas. But in case where the land exceeds 15 bighas, the excess land may be regularised in favour of their adult on 01.01.2000 and such land shall be entered in their joint tenancy. Provided that total area of land already held by such tenant and land so regularised shall not exceed Ceiling area applicable to them under the Rajasthan Imposition of Ceiling on Agricultural Holding Act, 1973."
