NOTIFICATION

In exercise of the powers conferred by section 100 of the Rajasthan Land Revenue Act, 1956 (Act No. 15 of 1956), the State Government hereby makes the following rules further to amend the Rajasthan Industrial Areas Allotment Rules, 1959, namely :-


1. Short title and Commencement.— (i) These rules may be called the Rajasthan Industrial Areas Allotment (Amendment) Rules, 2002.
(ii) They shall come into force from the date of their publication in the Official Gazette.
2. Amendment of rule 3.— In rule 3 A of the Rajasthan Industrial Areas Allotment Rules, 1959, after the existing proviso, following new proviso shall be added, namely :-

Provided further that for the allotment of Government agricultural land upto an area of four bighas for setting up of Tourism Units in rural areas upto 4 bighas, the price of the land shall be charged from that allottee which shall be 25% of the prevailing market price of the same class of agricultural land in the vicinity and subject to the condition that 100% unskilled work force from that local area shall be employed in such Tourism Units. The Tourism Unit shall be inspected from time to time by the officers of the Tourism Department not below the rank of Tourism Officer in the area under their jurisdiction. In the event of breach of condition of employment of 100% unskilled work force from that local area, the allotment shall be cancelled by the allotting authority on the recommendations of the

compensation.


