NOTIFICATION

In exercise of the powers conferred by clause (xviii) of of sub-section (2) of section 261 of the Rajasthan Land Revenue Act, 1956 (Rajasthan Act No. 15 of 1956) read with section 101 of the said Act, the State Government hereby makes the following rules further to amend the Rajasthan Land Revenue (Allotment of Land for Agro-based Export oriented Produce Purposes Rules, 1956,

- Short title and Commencement (1) These rules may be called the Rajasthan Land Revenue (Allotment, of Land for Agrobased Export oriented Produce Purposes)(Amendment)Rules,2002. (2) They shall come into force on the date of their publication in the Official Gazette.
- Amendment of rule 7 .- The existing rule 7 of the Rajasthan Land Revenue (Allotment of Land for Agro-based Export Oriented Produce Purposes) Rules, 1996 shall be substituted by the following, namely: -

"7. Lease Rent. - The annual lease fent for the Aland, alloted 对自己,你就是一个人的人的人,是 shall be as follows: -

- in the first year of allotment _ No lease rent. (i)
- from 2nd year to 5th year (ii)

(iii) after 5th to 10th year of allo ment

Rs. 300/- per hac.

(iv) after 1 th year to 15th year of allotment

(v) after 15 years

State Government shall review for re-determination of lease rent.

These rates of lease rent shall be applicable to allotment made within a period of five years from the date of commencement of the Rajasthan Land Revenue (Allotments of Land for Agro-based Export Oriented Produce Purposes (Amendment) Riles 2002 where after allotment shall be made on the lease rent as specified by the State Government from time to time. At the time of allotment an amount Rs.400/- per hac. or as determined by the State Government, shall be paid by the applicant."
