NCTTADIATION

In exercise of the powers conferred by classe (vi-A) of sub-section (2) of section 261 read with section 90. A of the Rajasthan Land Revenue Act, 1956 (Rajasthan Act No. 15 of 1956), the State Government hereby makes the following rules further to amend the Rajasthan Land Revenue (Conversion of Agricultural Land for Non Agricultural Purposes in Rural Areas) Rules, 1992; namely:-

Short title and commencement. (1) These rules may be ralled the Rajasthan hand Revenue (Convession of Agricultural Fand for Non Agricultural Purposes in Rural Areas )(Amendment) Jules, 2003.

(20They shall come into force on the date of their publication in the Official Gazet e.

Amendment of rule 4.— In rule 4 of the Rajast an Land Revenue (Conversion of Agricultural Land for Non Agricultural purposes in Rural Areas) Rules, 1992; (i) the existing clause(b) shall be substituted by the following: nemely:—

(b) Land falling within the boundary limits of any railway line, National Highway, State Highway or any other road maintained by the Central or State Government or any Local Authority, as specified in any Act or Rules of the Central or State Government made in this behalf, or within the limit prescribed by the industry department under the industrial policy for establishment of industry from the middle point of National Mighway/State Highway wichever is longer or the land falling within the 100 feet from the middle of any road or any rural pathway which link villages or public places, whether shown in the revenue map of a village or not.

(ii) the existing clause (c) shall be substituted by the following; namely:- "(c) land falling within the redius of 1.5 mm of outer limits of abadi of a village for the nurrose of an industrial unit or lime kiln or a Kreshar Unit or an Industrial area. This restriction shall not apply where the conversion is sought for brick kiln or hou-polluting industry, small or cottage industry".
