NOTIFICATION

In exercise of the powers conferred by clause (xi-a) of sub-section (2) of section 261 read with section 90-7, 102 of the Rajasthan Land Revenue Act, 1956 (Rajasthan Act No. 15 of 1956), and all other powers enabling it in this behalf, the State Government hereby makes the following rules further to amend the Rajasthan Land Revenue (Allotment, Conversion and Regularisation of Agricultural Land for Construction of Cinemas and for Establishment of Petrol Pumps or Medical facilities) Rules, 1978, namely:

1- Short title and commencement.-(i) These rules may be called the Rajasthan Land Revenue (Allotment, Conversion and Regularisation of Agricultural Land for Construction of Cinemas and for Establishment of Petrol Pumps or Medical facilities)(Amendment) Rules, 2003.

(ii) They shall come into force on the date of their publication in the Official Gazette.

2- Amendment of rule 1.- In rule 1 of the Rajasthan Land Revenue (Allotment Conversion and Regularisation of Agricultural Land for Construction of Cinemas and for Establishment of Petrol Pumps or Medical Facilities) Rules, 1978, hereinafter referred to as the said rules, the existing expression "Conversion" shall be deleted.

3. Amendment of rule 3.- In clause (b) of rule 3 of the said rules, the existing expression "Conversion and" shall be deleted.

4. Amendment of rule 4.- In rule 4 of the said rules, the existing heading and expression "Agricultural Land of which Conversion can not be made or Regularised.-Conversion or regularisation of the following land shall not be made or regularised, namely -"shall be substituted by the following:-

"Agricultural Land which can not regularised.-following land shall not be regularised; namely:-


5- Amendment of rule 6.-In sub-rule(I) of rule 6 of the said rules, the expression "if any person having a legal right to an agricultural land, intends to construct a Cinema house, or a

Hotel or to establish a petrol pumps there on or "shall be deleted.

6. Amendment to rule 9.- In rule 9 of the said rules:
 - (i) the existing expression "Conversion" wherever occurring shall be deleted.
 - (ii) The existing sub-rule (2), sub-rule (7) and sub-rule (13) shall be deleted.
7. Amendment of rule 9A.- In clause (2) of rule 9A of the said rules, the expression "Conversion", "Conversion or", "and conversions" and the expression "and Conversion of Agricultural Land" shall be deleted.
8. Amendment of rule 10.- In sub-rule (1) of rule 10 of the said rules, the expression "Converted" shall be deleted.
9. Amendment of rule 11.- In sub-rule (2) of rule 11 of the said rules, the existing expression "Convert" shall be deleted.
10. Amendment of Schedule I.- In Schedule I of the said rules, the expression "Conversion and " shall be deleted.
11. Amendment of Schedule II.- In schedule II of the said rules, the existing expression "Conversion" shall be deleted.
12. Amendment of FORM A, B and C.- In FORM A, B and C of the said rules, the expression "Conversion" wherever occurring shall be deleted.


