NOTIFICATION

In exercise of the powers conferred by sub-section (4) of section 4, read with clause (i) of sub-section (2) of section 261 of the Rajasthan Land Revenue Act, 1956 (Act No. 15 of 1956), the State Government hereby makes the following rules further to amend the Rajasthan Land Revenue (Qualifications and Conditions of Service of Chairman and Members of the Board) Rule, 1971, namely:-

**1. Short title and commencement.** - (1) These rules may be called the Rajasthan Land Revenue (Qualifications and Conditions of Service of Chairman and Members of the Board) (Amendment) Rules 2011.

(2) They shall be deemed to have come into force from 25th January, 2010.

**2. Amendment of rule 16.-** In rule 16 of the Rajasthan Land Revenue (Qualifications and Conditions of Service of Chairman and Members of the Board) Rules, 1971,-

(i) the existing sub-rule (3) shall be substituted by the following, namely:-

"(3) A member appointed from Advocates shall with effect from 25th January, 2010 be entitled to payment of pension at the rate of Rupees 30,000/- per-annum for each completed year of service subject to a maximum of Rupees 1,80,000/- per year.

**Explanation - "each completed year of service" includes -**

(i) actual service;

(ii) each period of leave on leave salary equivalent to full pay;

(iii) each period of leave on medical certificate on leave salary equivalent of half pay subject to the total of such periods of leave not exceeding 20 days per year of completed service."

(ii) the existing sub-rule (4) shall be deleted.

(iii) the existing sub-rule (5) shall be renumbered as sub-rule (4).
