NOTIFICATION

In exercise of the powers conferred by sub-section (1) of section 101 of the Rajasthan Land Revenue Act, 1956 (Act No. 15 of 1956) read with section 261 and 90 thereof, and section 28 read with section 7 of the Rajasthan Colonisation Act, 1954 (Act No. 27 of 1954) and of all other powers enabling it in this behalf, the State Government hereby makes the following rules further to amend the Rajasthan Gallantry Awards (Cash Rewards and Land Grants) Rules, 1966, namely:-

1. Short title and commencement: - (1) These rules may be called the Rajasthan Gallantry Awards (Cash Rewards and Land Grants) (Amendment) Rules, 2015.

(2) They shall come into force at once.

2. Amendment of rule 7.- The existing sub-rule (3) of rule 7 of the Rajasthan Gallantry Awards (Cash Rewards and Land Grants) Rules, 1966, hereinafter referred to as the said rules, shall be substituted by the following, namely:-

“(3) On receipt of application duly verified by Officer-In charge, Records Office, the Collector shall send the same to the Director, Sainik Kalyan Vibhag, Rajasthan, Jaipur to issue sanction in Form of Annexure ‘B’ of these rules and draw and disburse the amount to the applicant.”

3. Substitution of Annexure B.- The existing Annexure B of the said rules shall be substituted by the following, namely:-
