NOTIFICATION

In exercise of the powers conferred by section 28 read with section 7 of the Rajasthan Colonisation Act, 1954 (Act No. 27 of 1954), the State Government hereby makes the following rules further to amend the Rajasthan Colonisation (Allotment and Sale of Government Land in the Indira Gandhi Canal Colony Area) Rules, 1975, namely:-

- 1. Short title and commencement.- (1) These rules may be called the Rajasthan Colonisation (Allotment and Sale of Government Land in the Indira Gandhi Canal Colony Area) (Amendment) Rules, 2013.
- (2) They shall come into force at once.
- 2. Amendment of rule 13-A.- In clause (ix) of sub-rule (5) of rule 13-A of the Rajasthan Colonisation (Allotment and Sale of Government Land in the Indira Gandhi Canal Colony Area) Rules, 1975, herein after referred to as the said rules, for the existing expression "31st March, 2013", the expression "31st December, 2013" shall be substituted.
- 3. Amendment of rule 17.- In sub-rule (8) of rule 17 of the said rules, the existing second proviso shall be substituted by the following new provisos, namely:-

"Provided further that where the allottee fails to deposit the installments of price of land, no action for cancellation of allotment of land shall be taken by the allotting authority if the allottee deposits the remaining unpaid price of land without any interest as lump sum up to 31.12.2013.

Provided also that where the allotment of land has been cancelled for non-payment of installments of price of land and land has not been allotted to any other person, the allotment shall be restored if the allottee deposits the remaining unpaid price of land without any interest as lump sum up to 31.12.2013."

4. Amendment of rule 20.- In clause (i) of rule 20 of the said rules, the following new provisos shall be added, namely:-

"Provided that where the purchaser fails to deposit the installments of price of land, no action for cancellation of allotment of land shall be taken by the allotting authority if the purchaser deposits the remaining unpaid price of land without any interest as lump sum up to 31.12.2013.



Provided further that where the allotment of land by sale has been cancelled for non-payment of installments of price of land and land has not been resold to any other person, the allotment shall be restored if the purchaser deposits the remaining unpaid price of land without any interest as lump sum up to 31.12.2013."
