NOTIFICATION

In exercise of the powers conferred by section 100 of the Rajasthan Land Revenue Act, 1956 (Act No. 15 of 1956), the State Government hereby makes the following rules further to amend the Rajasthan Land Revenue (Allotment of Land for setting up of Power Plant based on Renewable Energy Sources) Rules, 2007, namely:-

1. Short title and commencement.- (1) These rules may be called the Rajasthan Land Revenue (Allotment of Land for setting up of Power Plant based on Renewable Energy Sources) (Amendment) Rules, 2025.

(2) They shall come into force at once.

2. Amendment of rule 6.-The existing sub-rule (3) of rule 6 of the Rajasthan Land Revenue (Allotment of Land for setting up of Power Plant based on Renewable Energy Sources) Rules 2007, shall be substituted by the following, namely:-

“(3) Premium of the land allotted for Renewable Energy Power Plant/RE Park shall be equal to two times of the market value of land determined on the basis of rate recommended by the DLC for the agricultural land. After 30 years, if the lease is renewed for a further period of 10 years, the premium shall be equal to two times of the market value of land, determined on the basis of rate recommended by the DLC for the agricultural land, at the time of renewal.”
