NOTIFICATION

In exercise of the powers conferred by section 100 No 15 of 1956), the State Government hereby makes the following rules further to amend the Rajasthan Industrial Areas Allotment Rules, 1959, namely :-

1. Short title and commencement.-(i) These rules may be called the Rajasthan Industrial Areas Allotment (Amendment) Rules, 2001.

(ii) They shall come into force the date of their publication in the official gazette.

2. Amendment of rule 2.— After clause (b) of rule 2 of the Rajasthan Industrial Areas Allotment Rules 1959, hereinafter referred to as the said rules, following new clause (c) shall be added, namely :-

"(c) All allotment of land under clause (a) shall be made within a period of 60 days and under clause (b) within a period of 30 days from the date of receipt of the completed applications in Form-B.

3. Addition of new Form-B.— In the said rules, after the existing Form-A, the following new Form-B shall be added, namely :-
