NOTIFICATION

In exercise of the powers conferred by clause (xi-A) of sub-section (2) of section 261 read with section 90-A of the Rajasthan Land Revenue Act, 1956 (Act No. 15 of 1956) the State Government hereby makes the following rules further to amend the Rajasthan Land Revenue (Conversion of agricultural land for non-agricultural purposes in rural areas) Rules, 2007, namely:-

- 1. Short title and Commencement.-(1) These rules may be called the Rajasthan Land Revenue (Conversion of agricultural land for non-agricultural purposes in rural areas) (Second Amendment) Rules, 2009.
- (2) They shall come into force at once.
- 2. Amendment of rule 10.- In rule 10 of the Rajasthan Land Revenue (Conversion of agricultural land for non-agricultural purposes in rural areas) Rules, 2007, hereinafter referred to as the said rules, -
 - (i) in sub-rule (3) for the existing expression "to whom land has been allotted" the expression "whose land has been converted" shall be substituted.
 - (ii) in sub-rule (4) for the existing expression "or sub-rule (2)" the expression "or sub-rule (3)" shall be substituted.
- 3. Amendment of Form C.- In Form C appended to the said rules, -
 - (i) in clause 2 the existing expression "or No. and date of the allotment order (Note: Enclose a copy of the order)." shall be deleted.
 - (ii) in clause (3) the existing expression "or Purpose for which the land was allotted." shall be deleted.

4. Amendment of Form D.- In clause 3 of Form D appended to The said rules the expression "or Purpose for which land was allotted, indicating the date and No. of the order." shall be deleted.
