-NOTIFICATION-

In exercise of the powers conferred by section 102 of the Rajasthan Land Revenue Act, 1956 (Act No. 15 of 1956), the State Government hereby makes the following amendments in this department's order No.F.5(109)Rev./B/60 dated 20-7-1963, as amended from time to time, pertaining to allotment of unoccupied Government Agricultural Land for the construction of Schools, Colleges, Dispensaries, Dharmshalas and other Building of Public Utility, namely:-

Amendments

In the said order, -

- 1. In clause 2 after the existing sub-clause (u) the following new sub-clause shall be added, namely:-
 - "(v) for erection of statue of a martyr killed in any defence operation Up to 500 Sq. mts."
- 2. After the existing last proviso to sub-clause (ii) of clause 3, the following new proviso shall be added, namely:-
 - "Provided also that land shall be allotted free of cost for the purpose mentioned in sub-clause (v) of clause 2, but such land shall be allotted only when the work of erection of the Statue/Memorial is sanctioned by the competent authority under the M.L.A. Local Area Fund Scheme or the concerned Collector is satisfied that adequate funds are available for this purpose through contribution / donation by the local people."
- 3. In sub-clause (ii) of clause 4 for the existing expression "and (u) of clause 2", the expression "(u), and (v) of clause 2" shall be substituted.
