Notification

In exercise of the powers conferred by section 102 of the Rajasthan Land Revenue Act, 1956 (Act No.15 of 1956) , the State Government hereby makes the following amendments in this department's order No.F.5(109)Rev./B/60 dated 20-7-1963, as amended time to time, pertaining to allotment of unoccupied Government Agricultural Land for the construction of Schools, Colleges, Dispensaries, Dharmshalas and other Buildings of Public Utility; namely:-

Amendment

In the clause 4-A of the said order ,-

1 the existing condition number (i) shall be substituted by the following, namely:-

" (i) the allotment shall be made on the lease hold basis for a period of 30 years and lease may be renewed for another such period, as the Government may decide from time to time. The land allotted prior to 31-1-2009, to Technical Institutions for a period of 25 years shall be deemed to have been allotted for a period of 30 years;"

2 The existing condition number (iii) shall be substituted by the following, namely:-

" (iii) the allotment of land shall not exceed 5 bighas for setting up of Industrial Training Institutions and 10 acres for setting up of Engineering Colleges and Polytechnic College, but for setting up of Engineering College and boys Polytechnic College the land shall only be allotted outside the Municipal limit of the city;"

3 The existing condition number (iv) shall be substituted by the following, namely:-


" (iv) the land shall be allotted under this clause for setting up of only one Engineering College and Polytechnic College in each Lagging District and for setting up of only one Industrial Training Institution in each Lagging block;"

(1) Technical Institutions means Engineering Colleges, Polytechnic College and Industrial Training Institutions."

5 the existing Explanation (2) shall be substituted by the following, namely:-


"(2)' Lagging districts' means the districts, which do not have any Engineering Colleges or Polytechnic College."
