NOTIFICATION

In exercise of the powers conferred by section 100 of the Rajasthan Land Revenue Act, 1956 (Act No. 15 of 1956), the State Government hereby makes the following rules further to amend the Rajasthan Industrial Areas Allotment Rules, 1959, namely:-

1. Short title and commencement.-(1) These rules may be called the Rajasthan Industrial Areas Allotment (Second Amendment) Rules, 2010.  
(2) They shall come into force from the date of their publication in the Official Gazette.

2. Amendment of rule 3-A. - After the existing last proviso to rule 3-A of the Rajasthan Industrial Areas Allotment Rules, 1959, the following new provisos shall be added, namely:-

"Provided also that for the allotment of Government agricultural land for establishment of offices/branches of National Laboratories like CLIR, CFTRI etc. in rural areas, the price of the land shall be charged from the allottee at the rate of 50% of the market rate determined by the District level Committee for the same/adjoining area of agricultural land, subject to the condition that the land is used only for the purpose for which the land is allotted and in the event of breach of condition, the allotment shall be cancelled by the allotting authority.


"Provided also that for the allotment of Government agricultural land for setting up of research, development and testing laboratories accredited from a national level Accreditation Board/Authority, by Micro, Small and Medium Enterprises Associations in rural areas, the price of the land shall be charged from the allottee at the rate of 50% of the market rate determined by the District level Committee for the same/adjoining area of agricultural land, subject to the condition that the land is used by the said Associations only for the purpose for which the land is allotted and in the event of breach of condition, the allotment shall be cancelled by the allotting authority."
