## **NOTIFICATION**

In exercise of the powers conferred by sub-section (2) of section 261 of the Rajasthan Land Revenue Act, 1956 (Act No. 15 of 1956), the State Government hereby makes the following rules further to amend the Rajasthan Land Revenue (Land Records) Rules, 1957, namely:-

- 1. Short title and commencement.- (1) These rules may be called the Rajasthan Land Revenue (Land Records) (Amendment) Rules, 2010.

  1. (2) They shall come into force at once.
  - 2. Amendment of rule 9. -The existing sub-rule (i) of rule 9 of the Rajasthan Land Revenue (Land Records) Rules, 1957, hereinafter referred to as the said rules, shall be substituted by the following, namely:-
  - " (i) The Collector may transfer a Patwari anywhere within the District and the Sub-Divisional Officer may also transfer a Patwari within the Sub-Division:

Provided that the State Government may direct the Collector to transfer a Patwari anywhere within the District.

Provided further that the State Government may transfer a Patwari, on his own request, from one District to another District, on such transfer, the Patwari so transferred shall rank junior to all existing Patwaries of the district to which he is transferred."

- 3. Amendment of rule 173.- The existing rule 173 of the said rules, shall be substituted by the following, namely:-
- " 173. Transfer.-The Collector may transfer an Inspector of Land Records anywhere within the District. The Board of Revenue may transfer an Inspector of Land Records from one District to another District:

Provided that the State Government may direct the Collector or the Board of Revenue, as the case may be, to transfer an Inspector of Land Records."

- 4. Amendment of rule 204. The existing rule 204 of the said rules, shall be substituted by the following, namely:-
- " 204. Transfer.-The Collector may transfer an Office Quanungo from one Tehsil to another Tehsil within the District. The Board of Revenue may transfer an Office Quanungo from one District to another District:

Provided that the State Government may direct the Collector or the Borad of Revenue, as the case may be, to transfer an Office Quanungo."
