NOTIFICATION

In exercise of the powers conferred by clause (XLIV) of sub-section (2) of section 261 read with section 102 of the Rajasthan Land Revenue Act, 1956 (Act No. 15 of 1956) the State Government hereby makes the following rules further to amend the Rajasthan Land Revenue (Allotment of Land in Saline Area) Rules, 2007, namely:-

1. Short title and commencement.- (1) These rules may be called the Rajasthan Land Revenue (Allotment of Land in Saline Area) (Amendment) Rules, 2011.

(2) They shall come into force at once.

2. Amendment of rule 15. - In rule 15 of the Rajasthan Land Revenue (Allotment of Land in Saline Area) Rules, 2007,-

- (i) in sub-rule (1), for the existing expression "with a late fee of Rupees five hundred within three months.", the expression "with a late fee of Rupees one thousand five hundred within three months and if the lessee fails to submit stamps and execute the lease deed even with late fee as mentioned above, the same may be submitted and executed with the additional late fee of rupees one hundred per day for further three months." shall be substituted.
- (ii) in sub-rule (1), for the existing expression "with a late fee as mentioned above", the expression "with a late fee and additional late fee as mentioned above" shall be substituted.
- (iii) in sub-rule (2), for the existing punctuation mark ".", appearing at the end, the punctuation mark ":" shall be substituted.
- (iv) in sub-rule (2), so amended, the following proviso shall be added, namely:-

"Provided that the lessee who did not apply for renewal in time or where application for renewal has been rejected on the ground that the application for renewal is not submitted within time limit, he may apply for renewal within a period of six

months from the date of commencement of the Rajasthan Land Revenue (Allotment of Land in Saline Area) (Amendment) Rules, 2011."
