NOTIFICATION

In exercise of the powers conferred by clause (xi-A) of sub-section (2) of section 261 read with section 90-A of the Rajasthan Land Revenue Act, 1956 (Act No.15 of 1956), the State Government hereby makes the following rules further to amend the Rajasthan Land Revenue (Conversion of agricultural land for non-agricultural purposes in rural areas) Rules, 2007, namely:-

1. **Short title and commencement.**-These rules may be called the Rajasthan Land Revenue (Conversion of agricultural land for non-agricultural purposes in rural areas) (Second Amendment) Rules, 2013.

(2) They shall come into force at once.

2. **Amendment of rule 2.**- In sub-rule (1) of rule 2 of the Rajasthan Land Revenue (Conversion of agricultural land for non-agricultural purposes in rural areas) Rules, 2007, hereinafter referred to as the said rules,-

(i) in sub-clause (g) of clause (r), for the existing punctuation mark “.”, the punctuation mark “;” shall be substituted.

(ii) in existing clause (s), for the existing punctuation mark “.”, the expression “; and” shall be substituted.

(iii) after clause (s), so amended, the following new clause (t) shall be added, namely:-

"(t) 'Wind Power Plant' means a group of wind turbines in the same location used for production of electric power;"

3. **Amendment of rule 3.**- In clause (xi) of rule 3 of said rules, after the existing expression “Solar” and before the existing expression “power”, the expression “/Wind” shall be inserted.

4. **Amendment of rule 7.**-In clause (xi) of rule 7 of the said rules, after the existing expression “Solar” and before the existing expression “Power”, the expression “/Wind” shall be inserted.

5. **Amendment of rule 8.**-In sub-rule (4) of rule 8 of the said rules, after the existing expression “of enterprise(s)” and before the existing expression “, holding a valid”, the expression “or for modernization/ expansion/ diversification of existing enterprise(s) or for revival of sick industrial enterprise(s)” shall be inserted.

6. **Amendment of rule 9.** - In sub-rule (3) of rule 9 of the said rules, for the existing expression “within 30 days”, the expression “within 45 days” shall be substituted.
