NOTIFICATION

In exercise of the powers conferred by section 261 of the Rajasthan Land Revenue Act, 1956 (Act No. 15 of 1956) read with section 101 and 102 of the said Act and the proviso to section 34 of the Rajasthan Tenancy Act, 1955 (Act No. 3 of 1955) and all other powers enabling it in this behalf, the State Government hereby makes the following rules further to amend the Rajasthan Land Revenue (Permanent Allotment of Evacuee Agricultural Land) Rules, 1963, namely:-

1. Short title and commencement.- (1) These rules may be called the Rajasthan Land Revenue (Permanent Allotment of Evacuee Agricultural Land) (Amendment) Rules, 2013.

(2) They shall come into force from the date of their publication in the Official Gazette.

2. Amendment of rule 6.- In sub-rule (4) of rule 6 of the Rajasthan Land Revenue (Permanent Allotment of Evacuee Agricultural Land) Rules, 1963, after the existing expression "illegal possession of unauthorised persons as trespassers" and before the existing expression, ",such lands," the expression "or as sub tenant" shall be inserted.
