NOTIFICATION

In exercise of the powers conferred by section 100 of the Rajasthan Land Revenue Act, 1956 (Act No. 15 of 1956), the State Government hereby makes the following rules further to amend the Rajasthan Land Revenue (Allotment of Land or Setting up Power Plant based on Renewable Energy Sources) Rules, 2007, namely:-

- 1. Short title and commencement.- (1) These rules may be called the ajasthan Land Revenue (Allotment of Land for Setting up of Power Plant based on Renewable Energy Sources) (Second Amendment) Rules, 2014.
- (2) They shall come into force at once.
- **2.** Amendment of rules 9.- In rule 9 of the Rajasthan Land Revenue (Allotment of Land for Setting up of Power Plant based on Renewable Energy Sources) Rules, 2007,-
 - (i) the existing sub-rule (2) shall be substituted by the following, namely,-
 - "(2) Where the Developer desires to sub-lease any of the area or part of the area allotted to him and his interest in the leased area for the purpose of generating the wind energy or solar energy, he may be allowed to do so by the Collector on recommendation of R.R.E.C. The transferee shall pay fifty percent additional lease rent annually."
 - (ii) In sub-rule (3), for the existing expression "Wind Energy Farm", the expression "Wind Farms, Wind Power Plant, Solar Parks and Solar Power Plant" shall be substituted.
