NOTIFICATION

In exercise of the powers conferred by sub-section (2) of section 261 of the Rajasthan Land Revenue Act, 1956 (Act No. 15 of 1956), the State Government hereby makes the following rules further to amend the Rajasthan Land Revenue (Land Records) Rules, 1957, namely:-

- 1. Short title and commencement:- (1) These rules may be called the Rajasthan Land Revenue (Land Records) (Amendment) Rules, 2015.
- (2) They shall come into force at once.
- 2. Amendment of rule 4.-In first proviso to sub-rule (b) of rule 4 of the Rajasthan Land Revenue (Land Records) Rules, 1957, hereinafter referred to as the said rules, for the existing expression "33 years", the expression "35 years" shall be substituted.
 - 3. Amendment of rule 273.- In sub-rule (4) of rule 273 of the said rules,-
 - (i) the existing clause (i) shall be substituted by the following, namely:-
 - (i) (a) He must have passed the 10+2/Senior Secondary School Examination or any other equivalent examination, recognised by the Government; and
 - (b) O or higher level certificate course conducted by the Department of Electronics Accreditation of Computer Course (DOEACC) under the control of the Department of Electronics, Government of India;

Computer Operator and Programming Assistant (COPA)/Data Preparation and Computer Software (DPCS) certificate course organized under the National Council on Vocational Training/ State Council on Vocational Training Scheme;

or

Diploma in computer Science/Computer Applications from a University established by law in India or from an Institution recognized by the Government;

Diploma in Computer Science and Engineering from Government recognized Polytechnic Institution;

or

Rajasthan State Certificate Course in Information Technology (RSCIT) conducted by Vardhman Mahaveer Open University, Kota under control of Rajasthan Knowledge Corporation Limited."

- (ii) in clause (iii) for the existing expression "30 years", the expression "35 years" shall be substituted.
- **4. Substitution of rule 284.-** The existing rule 284 of the said rules shall be substituted by the following, namely:-
 - "284. Selection of candidates for admission.- The Selection of candidates for admission to the school shall be from the Patwaries of Revenue and Land Records Department who promoted seniority-cum merit basis."
