NOTIFICATION

In exercise of the powers conferred by clause (xliv) of sub-section (2) of section 261 of the Rajasthan Land Revenue Act, 1956 (Act No. 15 of 1956), read with section 102 thereof, the State Government hereby makes the following rules further to amend the Rajasthan Land Revenue (Allotment of Land to Gaushalas) Rules, 1957, namely:-

- 1. Short title and commencement.- (1) These rules may be called the Rajasthan Land Revenue (Allotment of Land to Gaushalas) (Amendment) Rules, 2015.
- (2) They shall come into force at once.
- 2. Amendment of rule 8.- In sub-rule (3) of rule 8 of the Rajasthan Land Revenue (Allotment of Land to Gaushalas) Rules, 1957, hereinafter referred to as the said rules-
 - (i) for the existing punctuation mark ".", appearing at the end, the punctuation mark ":" shall be substituted.
 - (ii) at the end, the following new proviso shall be added, namely:-

"Provided that the Collector may, after recording reasons, grant lease for a period of thirty years or for so long as the lessee uses the area for the purpose of maintaining the cattle of the Gaushala, whichever is less, with the prior permission of the State Government."

3. Amendment in Appendix 'A'.-In Appendix 'A' of the said rules, for the existing expression "twenty years", wherever occurring, the expression "twenty years/thirty years" shall be substituted.
