NOTIFICATION

In exercise of the powers conferred by clause (b) of sub-section (1) of section 260 of the Rajasthan Land Revenue Act, 1956 (Rajasthan Act 15 of 1956) the State Government hereby directs that, the duties imposed and the powers conferred on the Revenue Appellate Authority mentioned in column No. 1 under the said Act, shall also be performed and exercised by the following of officers mentioned in column No. 2 during such period when the revenue Appellate Authority of the original jurisdiction mentioned in column No. 1 proceeds on leave or is permanently transferred.

In case Revenue Appellate Authority and first link officer as shown in column No. 1 and 2 are on leave or transferred the duties shall be performed by the 2nd link officer shown in column No. 3. When the Revenue Appellate Authority, first link officer and second link officer as shown in column No. 1, 2. and 3 are on leave or transferred the duties shall be performed by the third link officer as shown in column No. 4
