NOTIFICATION

In exercise of the powers conferred by sub-section (2) of section 261 of the Rajasthan Land Revenue Act, 1956 (Act No. 15 of 1956), the State Government hereby makes the following rules further to amend the Rajasthan Land Revenue (Land Records) Rules, 1957, namely:-

- **1. Short title and commencement.-** (1) These rules may be called the Rajasthan Land Revenue (Land Records) (Amendment) Rules, 2017.
- (2) They shall come into force with effect from 1st July, 2017.
- **2. Amendment of rule 12.-** In rule 12 of the Rajasthan Land Revenue (Land Records) Rules, 1957, hereinafter referred to as the said rules,-
 - (i) in existing marginal heading, for the existing expression "residence", the expression "office and residence" shall be substituted;
 - (ii) in sub-rule (i), the existing expression "No Patwari shall, however, be allowed to reside at a place beyond a radius of 3 miles from the limits of his circle except under very special circumstances." shall be deleted; and
 - the existing sub-rule (ii) shall be substituted by the following, namely:-
 - "(ii) A government building shall be provided to the Patwari at his posting place for the purpose of his office (Patwar Ghar). In case the government building is not available for his office (Patwar Ghar), rented building shall be arranged. The rent of such building shall be determined by the State Government.
 - (iv) A government building shall be provided to the Patwari at his posting place for the purpose of his residence. In case the government building is not available for his residence, he shall be entitled to get house rent allowance in accordance with the prevailing rules."
- **3. Insertion of rule 176-A.-** After the existing rule 176 and before the existing rule 177 of the said rules, the following new rule 176-A shall be inserted, namely:-



- "176-A. Obligation of office and residence.- (1) A government building shall be provided to the Inspector Land Records at his posting place for the purpose of his office. In case the government building is not available for his office, rented building shall be arranged. The rent of such building shall be determined by the State Government.
- (2) A government building shall be provided to the Inspector Land Records at his posting place for the purpose of his residence. In case the government building is not available for his residence, he shall be entitled to get house rent allowance in accordance with the prevailing rules."
