NOTIFICATION

In exercise of the powers conferred by clause (xi-A) of sub-section (2) of section 261 read with section 90-A of the Rajasthan Land Revenue Act, 1956 (Act No. 15 of 1956), the State Government hereby makes the following rules further to amend the Rajasthan Land Revenue (Conversion of agriculture land for non-agriculture purposes in rural areas) Rules, 2007, namely:-

- 1. Short title and Commencement.- (1) These rules may be called the Rajasthan Land Revenue (Conversion of agriculture land for non-agriculture purposes in rural areas) (Second Amendment) Rules, 2024.
- (2) They shall come into force at once.
- 2. Amendment of rule 9.- In sub-rule (1) of rule 9 of the Rajasthan Land Revenue (Conversion of agriculture land for non-agriculture purposes in rural areas) Rules 2007,-
 - (i) for the existing expression "an application online or in physical format to the authority", the expression "an application online to the authority" shall be substituted; and
 - (ii) for the existing expression "If application is submitted online than hard copy of complete application shall also be required to submit within 7 days to the prescribed authority", the expression "and a hard copy of complete application shall also be submit within 7 days to the prescribed authority" shall be substituted.
